

## **SBC North America Digital Online Poker Tournament Terms & Conditions**

### **1. Tournament Details**

Entry fee: free to enter for all SBC North America Digital (<https://sbcevents.com/sbc-digital-north-america>) delegates, registered according to SBC Events registration terms.

Buy-in: free, starting chips stack is provided to every registered player on no condition basis.

Number of entrants: a minimum of 2 and a maximum of 3000.

Location: online application hosted by EvenBet Gaming Limited, available at <https://sbc.evenbetgaming.com>

Start time: 9<sup>th</sup> of June 2021, 17:30 EST. The scheduled commencement time for the Tournament (or Satellite) is approximate and the organisers reserve the right to alter the start time due to unforeseen or extenuating circumstances. All entrants will be given a reasonable notice that the commencement time is altered.

### **2. Conditions of entry**

Applications for entry to a tournament may be made directly at the tournament location before the tournament commencement. To apply, a player must register at the website

<https://sbc.evenbetgaming.com>, using his true name or unique nickname, and valid email.

Organisers reserve the right and license to use selected entrants' names, nicknames, game screenshots, and tournament results for informational and promotional purposes.

Entrants acknowledge and agree that all tournament results are saved on EvenBet Gaming Limited servers and are available for organisers.

### **3. Tournament format**

Tournament will consist of one or more rounds played on one or more tables. The number of tables will be determined by a number of entries received. Tables designated for use during the tournament will be used exclusively for tournament play.

The game of No Limit Texas Hold'em will be played. Standard game rules apply.

Entrants will be allocated at tables at the tournament commencement automatically.

All bets will be made with "play money" chips.

Late registration will be available. The time period available for late registration will be determined by the organisers, with a minimum of 30 minutes after the tournament commencement.

The betting limits together with the increases in blinds and/or antes will be determined by the organisers and announced to all entrants prior to the commencement of the tournament.

Entrants in a tournament will be eliminated from that tournament when they have lost their bank and no further re-buys or add-ons are allowed. Players that are eliminated from a tournament, cannot re-enter. Re-buys and/or add-ons policy will be announced to all entrants at their registration in a tournament. As entrants are eliminated from the tournament, the number of tables may be reduced; in that case, re-seating will be proceeding automatically when there are no active hands played at any of the tournament tables.

### **4. Winners and prizes**

The winner(s) of the tournament will be the last remaining entrant(s) remaining in the tournament after all other entrants have been eliminated.

Organisers will provide 3 (three) guaranteed prizes given as Amazon.com gift vouchers equal to:

1<sup>st</sup> place – USD500

2<sup>nd</sup> place – USD200

3<sup>rd</sup> place – USD100.
